The Pensioner Income Maximisation Service can help people aged over 60 with all areas of benefits, for example;

- If your health has recently deteriorated you may be entitled to a Health Benefit such as Disability Living Allowance or Attendance Allowance
- If you live on a low income we could help you to claim Income Top up benefit, Pension Credit
- We can also check if you are entitled to, and help you to claim, Housing and Council Tax Benefits
- And if you care for a relative then you may be entitled to Carers Allowance or a carer's premium.
- Similarly, if a relative cares for you then they may be entitled to Carers Allowance.

As well as giving information and Advice on Benefits the service can also help with other issues including;

- Housing – If you are having problems with disrepair in your house or problems with rent arrears
- Energy – We could help you gain access to grants to help with insulation and central heating systems and also give you advice on using your energy wisely and cutting your fuel bills
- Money – We can help you to deal with any debts or payments that you may be struggling to meet
